

**ACE HARDWARE “CUSTOMER ENGAGEMENT SURVEY” PROMOTION  
OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

**PROMOTION ENTRY PERIOD:** The **Ace Hardware® Customer Engagement Survey Promotion** begins at 12:00:01 AM Eastern Time (“ET”) on Monday, January 01, 2024 and ends at 11:59:59 PM ET on Tuesday, December 31, 2024 (the “Promotion Period”).

**ELIGIBILITY:** The Ace Hardware® Customer Engagement Survey Promotion (the “Promotion”) is only open to legal residents of the 50 United States of America and the District of Columbia, who are 18 years of age or older at time of entry. Void outside the U.S. and wherever else prohibited by law. Employees of Ace Hardware Corporation (the “Sponsor”) and its parents, members, affiliates, subsidiaries and agencies, and their immediate family members (spouse, parents, children and siblings, and their respective spouses) and persons living in the household of each are not eligible to participate. All federal, state and local laws and regulations apply.

**ENTRY:** There are two (2) ways to enter.

**Method #1:** Survey Receipt Invite - To enter participants must, make a purchase at a participating Ace Hardware store to receive a specially-marked cash register receipt which will have instructions inviting participants to visit <https://talkto.acehardware.com/>, enter the Journal # located on the receipt (the “Code”), answer any required customer satisfaction survey questions and provide their contact information. Participants must follow online instructions at the designated website for entering Codes. Participants will be invited to complete an online survey. The answers to the survey will have no effect on a participant’s ability to enter or win. Upon completion of the survey, the participant will be invited to complete the entry form in its entirety and submit to receive one (1) Promotion entry for the month (the “Survey Entry”) during which the entry is received. Entrants must have a Code and it must be entered exactly as they appear on the receipt to be entered into the sweepstakes. Submissions without a Code will not be entered into the sweepstakes. Each Code may only be entered one (1) time during the Promotion Period and cannot be re-used. Sponsor’s computer is the official clock for this Promotion. Proof of entry does not constitute proof of submission. All Codes are subject to verification. Online entrants are subject to all notices posted online including but not limited to the Sponsor’s Privacy Policy.

**Method #2:** Survey No Receipt - To enter visit <https://talkto.acehardware.com/>, select your store from a series of dropdowns, and complete an online survey. The answers to the survey will have no effect on a participant’s ability to enter or win. Upon completion of the survey, the participant will be invited to complete the entry form in its entirety and submit to receive one (1) Promotion entry for the month (the “Survey Entry”) during which the entry is received.

**Method #3:** Ace Rewards - To enter participants must, make a purchase at a participating Ace Hardware store and can link your purchase to your Rewards profile at checkout. The participant will be sent a customized invitation via email to complete an online survey. The answers to the survey will have no effect on a participant’s ability to enter or win. Upon completion of the survey,

the participant will be invited to complete the entry form in its entirety and submit to receive one (1) Promotion entry for the month (the "Survey Entry") during which the entry is received.

**Method #4:** AMOE (Alternate Means of Entry) - To enter the Promotion without making a purchase at an Ace Hardware store or without completing the survey, hand print your name, complete address, city, state, zip code, daytime phone number, and birth date on a 3" x 5" card and mail it to: Ace Hardware® Customer Engagement Survey Promotion Entry, PO Box 728, Social Circle, GA 30025-728. Mailed entries must be postmarked by the Entry Period End Date and received by the date indicated in the chart below, to be eligible for that Survey Period drawing. Each mail-in entry must be mailed in a separate outer envelope. No copies, facsimiles or mechanical reproductions will be accepted. Limit one (1) mail-in entry per post-marked envelope. Partially completed and/or mechanically reproduced entries or rubber-stamped entries will be void and ineligible. All entries received become the sole property of Sponsor and will not be returned. Sponsor will not be responsible for illegible, late, lost, mutilated, misdirected, postage due or stolen manual entries.

In arbitration, there is no judge or jury and review is limited. The arbitrator's decision and award are final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action or proceeding arising out of or relating to this Sweepstakes shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. ("JAMS") or any successor to JAMS. In the event JAMS is unwilling or unable to set a hearing date within fourteen (14) days of the filing of a "Demand for Arbitration", then either party can elect to have the arbitration administered by the American Arbitration Association ("AAA") or any other mutually agreeable arbitration administration service. If an in-person hearing is required, then it will take place in DuPage County, Illinois. The federal or state law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the dispute must be brought in a court of competent jurisdiction in DuPage County, Illinois. Sponsor agrees to pay the administrative and arbitrator's fees in order to conduct the arbitration (but specifically excluding any travel or other costs of entrant to attend the arbitration hearing). Either party may, notwithstanding this provision, bring qualifying claims in small claims court.
